
### **Participation Exemption Request Form**

Home Health Agencies who have served fewer than 60 HHCAHPS-eligible patients in a year (April 1, 2022 – March 31, 2023) are exempt from fielding the survey. A Participation Exemption Request (PER) form must be completed each year, even if you have completed one in the past. The APU 2025 PER is available <a href="here">here</a>.
