HCAHPS

Public Reporting Refresh

HCAHPS data published on <u>Care Compare</u> and in the <u>Provider Data</u> <u>Catalog</u> have been updated to display survey results from Q1 2022 – Q4 2022 (1/1/2022 – 12/31/2022) and updated Star Ratings.

The refresh, originally scheduled for October 2023, was postponed to November 8, 2023.

Preview Reports

Preview Reports containing HCAHPS scores from Q2 2022 – Q1 2023 (4/1/22 to 3/31/23) and Star Ratings are available through the <u>Hospital</u> Quality Reporting (HQR) portal through November 17, 2023. These results will be displayed on <u>Care Compare</u> and in the <u>Provider Data</u> <u>Catalog</u> with the January 2024 refresh.

HCAHPS

HCAHPS 2.0

The FY 2024 IPPS Rule finalized changes to HCAHPS Survey administration including web-first mixed-modes and lengthening the data collection period. These changes will be implemented beginning with January 1, 2025 discharges.

CMS has announced that, pending future rulemaking, changes will be made to the HCAHPS Survey to also take effect on January 1, 2025. CMS will provide information on the updated HCAHPS Survey, known as HCAHPS 2.0, at a future date.

Public Reporting Refresh

HHCAHPS results from Q2 2022 – Q1 2023 (4/1/2022 – 3/31/2023) are now displayed on <u>Care Compare</u>. These scores plus additional information including state and national averages, Star Ratings cut points, and patient-mix coefficients are available on the <u>HHCAHPS website</u> under General Information > <u>Archived Publicly Reported Data</u>.

OAS CAHPS

Public Reporting Refresh

OAS CAHPS data in the <u>Provider Data Catalog</u> have been refreshed to display results from patients who received procedures from Q2 2022 – Q1 2023 (4/1/2022 – 3/31/2023). Results are accessible at facility, state, and national levels in downloadable databases.

Public Reporting Schedule

CMS issued a revised public reporting schedule. When OAS CAHPS becomes linked to reimbursement in 2024 for HOPDs, public reporting of results will be included on the <u>Care Compare</u> website in addition to the <u>Provider Data</u> <u>Catalog</u>. To facilitate the transition and allow for a full four-quarter update, there will be no data refresh in July 2024. Data from the April 2024 refresh will remain frozen until October 2024.
